G.2. Block 40 Lot 11.12 - 2 Militia Road - Stephen E. Parker, P.E.

Time heard 7:48 PM

Stephen Parker, a NJ licensed engineer with Parker Engineering, appeared before the board on behalf of the applicant as a result of a real estate transaction. A basin flood and pit bail test were performed and resulted in some water movement but did not meet the requirements. The proposed designed disposal field was increased by 25% and an ATU system is proposed to be installed. Steve Parker read the Hunterdon County Health Department review letter and discussed all points. The engineer is asking for a waiver to be granted

by the board to allow for the zone of treatment to be 18" in thickness, which is allowed under State Code when an ATU is proposed whereas Readington Township ordinance requires a minimum of 48" in the zone of treatment. The proposed ATU system will require an annual inspection by a licensed service provider. A deed restriction will need to be filed for the pump system. The engineer resists the HCHD's recommendation to include stating the disposal system cannot be expanded in the future and the house can only be kept as a 3-bedroom dwelling in the deed restriction since there are sufficient policies and procedures in place for any future proposed expansions. The engineer also discussed the benefits of the Ecoflo Coco filter ATU system to the board. There are no wetlands within 150 ft.
