



BUDGET INFORMATION & SCHEDULE

- The Readington Township 2025 Budget is scheduled for introduction May 19, 2025.
- An introduced budget is required to be available to the public for 28 days prior to the public hearing and consideration of adoption and will be available via:
 - the Township Website
 - Available in the Clerk's Office between the hours of 8:30 am 4:30 pm
- The Township Committee will consider adoption of the 2025 Municipal Budget following a public hearing at the June 16, 2025, regular Township Committee Meeting







2025 MUNICIPAL BUDGET APPROPRIATIONS








2025 BUDGET MESSAGE

- The 2025 Tax Rate for consideration is \$0.549
 - A proposed \$0.04 increase

- The average homeowner in 2024 paid \$ 2,304.23 in Municipal Taxes tax rate of .508
- The average homeowner would pay \$ 2,490.20 in Municipal Taxes with the 2025 proposed .549 tax rate

PROPERTY TAX OVERVIEW

- By law, Municipalities are required to adopt a balanced budget, our appropriations (expenditures) must equal our revenues.
- The tax rate is calculated by dividing the total dollar amount to be raised by taxation by the total assessed value of all its taxable property multiplied by 100.
- A homeowner's property tax is calculated by multiplying the tax rate by the assessed value of their property divided by 100.

WHAT RESIDENTS GET FOR THEIR TAX DOLLAR

Police Department

- Four full patrol squads
- Full-time Detective Division
- Class III Officers in each public school
- Traffic and K-9 Units
- Outreach Police Officer

Community Outreach Team

- Outreach Police Officer who holds an MSW (Master of Social Work)
- Director of Social Services and Housing who is a LCSW (Licensed Clinical Social Worker)
- Support for residents in times of the crisis
- Follow up on cases to ensure that the needs of individuals and the community are being met as completely and practically as possible

WHAT RESIDENTS GET FOR THEIR TAX DOLLAR

Fire, EMS and OEM

- Support to Readington, Whitehouse and Three Bridges Fire Companies and Whitehouse Rescue Squad to protect the community including:
 - Providing the required PEOSHA fire equipment, gear, apparatus and trucks
 - Training
 - Maintenance of Facilities
- Coordination on larger scaled incidents through the five (5) key functions of Emergency Management: Planning, Preparedness, Response, Recovery and Mitigation

Public Works & Parks

- Maintenance of 6 Parks, multiple Public Buildings and 50 miles of Open Space Trails
- Stormwater Maintenance
- Storm Response (snow, flooding, trees down)
- Maintenance of 125 miles of Township Roadways
- Sewer Utility
- Recycling drop off facility
